

- 4. Copy of intimation regarding change within 60 days.**
- 5. Original License (Form B).**
- 6. Registration Certificate in case change in name of business**
- 7. Required affidavit.**
- 8. NOC from the left out Legal Heirs of the deceased in the shape of Affidavit duly attested by Notary in case the death/retirement of sole proprietor, legal heir to operator as sole proprietor.**
- 9. Retirement Deed/Death Certificate in case the death/retirement of sole proprietor, legal heir to operator as sole proprietor.**
- 10. Attested copy of Rent Agreement/Rent Deed/Ownership of the new premises in case change in place of business.**
- 11. Correction fee of Re. 1/- only.**
- 12. NOC from all the partners in case of change of business premises, change in particulars of business and change in name of business.**


